AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the of the NCTE ACT, 1993, the Regional Committee, NCTE hereby grants recognition to MIT College of Education for women, Khasara No. 119/1C, 119/1D, 2nd Street, M.Pudupatti Village & Post, Musiri Taluk, Trichy City, Tiruchirapalli District-621 211, Tamilnadu for conducting B.Ed programme of two years duration with an annual intake of 100 students (two units) from the academic sessions 2015-2016 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - V. The institution shall comply with the additional facilities required (additional builtup area, additional staff, additional funds etc) for the second unit as prescribed in NCTE (Recognition Norms and Procedure) Regulations 2014 before 31.10.2015.

2. AND WHEREAS, as per the request of the institution a Corrigendum was issued vide order no. F.SRO/NCTE/SRCAPP1997/B.Ed./TN/2015/63056 dt. 30.03.2015 as under:-**Instead of Words – MIT College of Education for Women, Khasara no. 119/1C, 119/1D, 2nd Street, M. Pudupatti Village & Post, Musiri Taluk, Trichy City, Tiruchirapalli District – 621211, Tamilnadu May Be Read As – Lord Jegannath College of Education, Kh no. 892/4, 11, 917/2, Plot no. 892/4 Part, 892/11, 917/2, PSN Nagar, Marungoor Village, Kumarapuramthoppur Post Office, Agastheeshwaram Taluk, Kanyakumari District, Tamilnadu-629402.**

3. AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 taken the decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulation, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 11.03.2022. The institution has not submitted reply to the Show Cause Notice.

4. AND WHEREAS the SRC in its 434th Meeting held on 22nd March 2024 the matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 10.04.2024. The institution has submitted reply of Final Show Cause Notice vide letter received on 06.06.2024. The SRC in its 438th Meeting held on 03rd June, 2024 has considered and the committee decided to issue Last Reminder Letter to the institution. The institution has submitted reply of website uploaded minutes vide e-mail dated 13.06.2024.

5. AND WHEREAS, the SRC in its 439th meeting held on 14th June, 2024 has considered the matter and decided as under:-

"The original file of the institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC, NCTE after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the institution Lord Jegannath College of Education, Survey No. 892/4, 11, 917/2, Marungoor Village Panchayat, Ramanathichenputhooor, Agasteeswaram Taluk, Kanyakumari District, Tamilnadu-629402 for B.Ed. programme 2 basic units of 50 students each."


